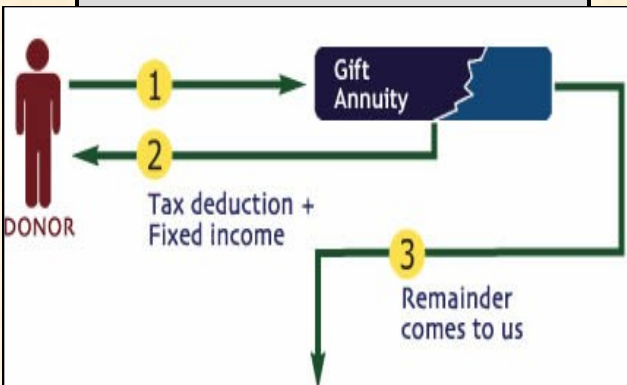


## About Charitable Gift Annuities

To create a charitable gift annuity, a donor transfers an asset to a charity. In turn, the charity agrees to make payments to the donor(s) for life. While a CGA can be funded in a number of ways, the most common are with a gift of cash or appreciated shares of stock. The graphic below shows the highlights of how a CGA works:



Not only is there an immediate charitable income tax deduction, you will receive a fixed rate of income for life—a portion of which may be tax free. Best of all, this gift annuity will help the Masonic Home fulfill its promise to future generations.

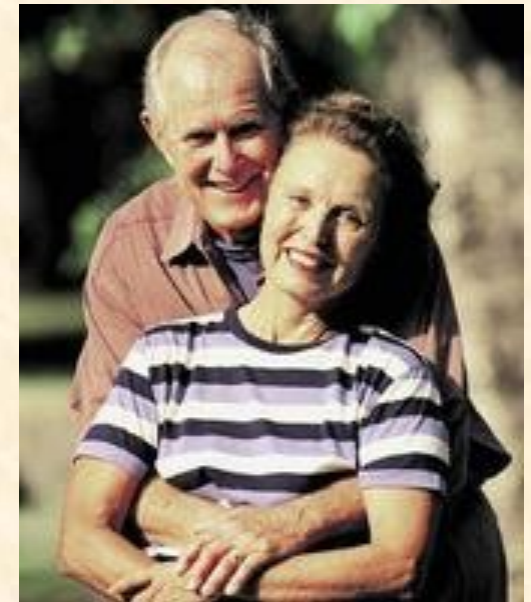
